# Notice of Changes of Representative Directors and Management Structure

Pasona Group Inc. (the "Company") hereby announces that, at the Board of Directors meeting held today, it has resolved to change the Company's representative directors and management structure as follows.

# 1. Change of Representative Directors

# (1) Reason for Change

This year marks the 50th anniversary of the Company's founding in 1976. This year, the Company is aiming to create a well-being industry, such as by exhibiting a pavilion at the 2025 Osaka-Kansai Expo. The Company is also working on developing a growth strategy with an eye on the next 50 years.

On the occasion of this milestone year, Mr. Yasuyuki Nambu, Group CEO and President, with the hope that the younger generation will build the new Pasona Group for the next 50 years, has offered to resign as Representative Director and Director of the Company, effective as of May 31, 2025 (the end of the fiscal year ending May 2025), and the Company has accepted the resignation.

From now on, the Company will move to a new management structure and, amid the significant changes in the environment surrounding the Company's group, such as the arrival of the full-fledged AI era and the rapidly changing international situation, the Company will further speed up the Company's management decisions and implementation, and under the new management structure, the Company will work to achieve sustainable growth and improve corporate value.

Please note that, regarding this matter, the candidates for representative director and director have been appointed by the Board of Directors after deliberation and reporting to the Board of Directors by the voluntary advisory Nomination and Compensation Committee.
